Arnold Schwarzenegger was born in Tahl bei Graz, Austria on July 30, 1947 and emigrated to the United States at the age of 21. In 1979 he received a BA in business from the University of Wisconsin. In 1984 he became a naturalized U.S. citizen.

In 1990, he was appointed by President Bush as Chairman of the President's Council on Physical Fitness and Sports and also served as the Chairman for the California Governor's Council on Physical Fitness and Sports under Governor Pete Wilson. In 1995 he founded the Inner City Games Foundation (ICG). He authored and chaired the School Education and Safety Act of 2002 (Proposition 49), which was overwhelmingly approved by voters. Following a successful career in business and entertainment, on November 17, 2003 he was sworn in as the 38th Governor of California.

Among Governor Schwarzenegger's many public service awards are the Muhammad Ali Humanitarian Award, the Simon Wiesenthal Center "National Leadership Award" and the Boys and Girls Town "Father Flanagan Service to Youth Award" for his efforts with Inner City Games and Special Olympics.

Governor Schwarzenegger and his wife of 17 years, broadcast journalist Maria Shriver, have four children — Katherine, Christina, Patrick and Christopher.
