

# New York State Executive Branch

The Governor of New York is both the central figure in the State's public affairs and the chief executive officer of the State. He initiates programs, executes them, guides the legislature, appoints and removes key officials, and represents the state and the people. The Governor appoints and removes the heads of most state agencies and proposes the budget. The executive budget is the strongest managerial tool provided to the Governor by the Constitution, and the Governor has primary responsibility for preparing budget recommendations. The Governor has power to grant reprieves, commutations and pardons after conviction for all offenses except treason or in cases of impeachment. The Governor also may remove certain local officials and may appoint certain judges and local officials to complete terms or fill vacancies. The Governor is commander-in-chief of the state's military and naval forces.

## Governor, NYS, Pataki, George E.

Governor Pataki was elected the 53rd Governor of New York State on November 3, 1998.

George Pataki began his public career in 1982 when he was elected as Mayor of Peekskill, the youngest Mayor in the City's history. In 1984, he was elected to the New York State Assembly where he was Ranking Minority Member of the Assembly on both the Education and Environmental Conservation Committees. Mr. Pataki was elected to the New York State Senate in 1992, where he served as Chair of the Senate Ethics Committee and was a member of the Environmental Conservation, Housing, Social Services, Banks and Codes Committees.

Governor Pataki was born June 24, 1945 to Louis and Margaret Pataki. Mr. Pataki graduated from Yale University in 1967 and received his law degree from Columbia University School of Law in 1970. He is married to Elizabeth (Libby) Rowland and they have four children: Emily, Teddy, Allison and Owen.

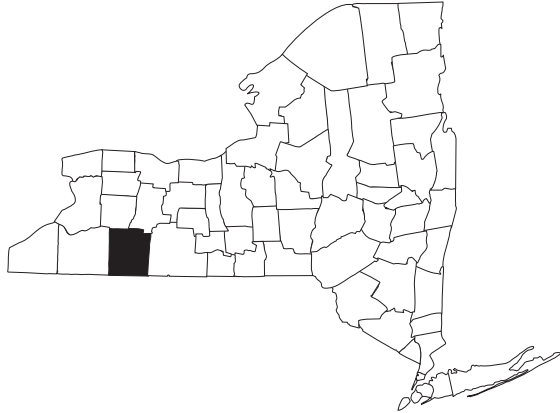
